

**ACT 2006-586**

“(a) Any taxpayer engaged at one location in more than one line of business failing within separate NAICS sector or sub-sectors, for which a business license is or may be required by the municipality in accordance with this chapter, shall take out and pay for a license for each separate NAICS sector or sub-sectors from which the taxpayer derived more than 10 percent of its gross receipts which shall be taxed with regard to such license shall, except as provided in subsection (c) and other provisions of this act, be only those gross receipts which arise within the line of business which is the subject of the license.”
